2018 REAP APPLICATIONS

There were 37 REAP applications from 42 eligible applicants. There are 3 Regional applications, 6 third year applications, and 9 second year applications. A breakdown of the type of applications include: 13 for water related, 2 for storm sirens, 12 for streets and sidewalks, 2 for sewer, 5 for buildings, 2 safety and emergency related equipment, and 1 utility. The total requested is \$1,808,657.56, but there is only \$872,837 available from the state allocation to be awarded. The executive committee will score all applications beginning at 3:00 p.m. on Thursday, Nov. 16th prior to the regularly scheduled meeting. The results will be posted on our website www.ascog.org Friday, December 15th.

2018 CDBG GRANT APPLICATIONS

Eligible applicants should start preparing and taking appropriate action NOW if they intend to apply for a CDBG. Every year, some will wait until it is too late to get the required meetings and other actions completed. Public hearings must be advertised at least 7 days prior and then you have to have a meeting to confirm what was done in the public hearing. Also, Low-to-Moderate Income (LMI) Surveys may be necessary to qualify. If federal funds are to be used for engineering, a Request for Qualifications (RFQ) process is mandatory. Engineering plans and specs take time, so you should be talking to engineers now. are any questions, please contact CED REMEMBER, ASCOG staff writes CDBG applications at no cost to you. Independent grant writers often charge as much as 3-5% to just write the application. If you do not use ASCOG to administer the grants, you must advertise for bids for grant administration. Fees for grant administration are paid with grant funds regardless of whether you use ASCOG or an independent. Do not be deceived if an independent grant writer accompanies an engineer to your meeting promising a "turn key" job. They cannot do anything ASCOG cannot do. 
