REAP Spotlight

City of Anadarko 2019 REAP project.

These are photos of the South David Street in Anadarko. The City of Anadarko requested \$44,667.00 and had a cash match of \$45,000.00. The South David Street was very rough and the base had eroded. The project called for reworking the base of the roadway and replacing the surface with concrete. Also, drainage issues were addressed particularly since the overflow of the water plant continued to contribute to the problem.



Preparing for Future Funding

Most communities will from time to time depend on federal funding to achieve their goals. This requires being eligible to apply for funding from such sources as the Economic Development Administration, Housing Urban Development and USDA Rural Development grants. So, what are the things communities should do now to prepare for these grants? Tom Zigler lays out a few of the highest priority items each community needs to have ready now. First, and most important every community needs to have their current audit or agreed-upon procedures to be eligible



federal funding. If you do not have an auditor or accountant, call us. Second, each community needs to apply for and maintain a DUNS number and ensure you are on the SAMS.gov registry. We can help with that, too. Third, every local government should have an updated five-year plan. If you do not have one, contact Tom and his team. In preparing a five-year plan, it is good to have a Capital

USDA Rural Development Business Grants

What does this program do?

This program is designed to provide technical assistance and training for small rural businesses. Small means that the business has fewer than 50 new workers and less than \$1 million in gross revenue.

What is an eligible area?

Rural Business Development Grant money must be used for projects that benefit rural areas or towns outside the urbanized periphery of any city with a population of 50,000 or more.

What kind of funding is available?

There is no maximum grant amount; however, smaller requests are given higher priority. There is no cost sharing requirement. Opportunity grants are limited to up to 10 percent of the total Rural Business Development Grant annual funding.

CARES Act Recovery Efforts Continue

What is The Oklahoma LivingChoice Program?

The Oklahoma Living Choice Program assists Oklahomans wanting to transition out of a nursing home and back into a residence of their own. To date, the program has helped transition over 800 residents back into their communities and has saved the state nearly \$8.5 million in rebalancing funds.

WHO QUALIFIES?

Individuals who currently live in a nursing home and qualify for SoonerCare. This program is specifically designed for persons 19 years and older with physical disabilities, and persons 65 years old and

disability doesn't mean you can't enjoy the comforts of your own home.

Services Offered

Depending on an individual's needs, services may include:

- Assistance with finding a new residence
- · Home-delivered meals
- Transportation
- Skilled nursing
- Therapy services
- Personal care
- Medication management
- Transitional funds (one-time allotment of up to \$2,400)

WHO CAN MAKE A REFERRAL? If you or a loved one meets requirements to qualify, then a referral for this program can be made by an individual, family member, a physician or other interested party/person.

The referred individual's name, address, phone number and Sooner-Care/Medicaid ID number.

T-Mobile for Education Offers Free Internet Access and Mobile Hotspots:

Close the Homework Gap, T-Mobile has stepped up to ensure our kids are staying connected. Families across the United States are facing challenges in 2020 and T-Mobile is

stepping up to ensure connectivity is not one of them. T-Mobile launched its T-Mobile 10Million Project just over 6 weeks ago. The 10Million Project, is designed to award 2 million hotspots a year over the next 5 years across the United States. Included with the hotspot is 100 GB of data for a year for a 5-year period. The State of Oklahoma has been awarded 22,000 FREE mobile hotspot devices with education grade filters on all devices to eligible students and approximately 1,900 currently have been distributed.



Each school district across the state is eligible to apply for the hotspots. In order to qualify the students must be in grades K-12, do not have internet at home and a household with at least one child in the National School Lunch Program (NSLP).

Not only is each school district eligible to apply for the hotspots but T-Mobile is offering additional data and tablets at a discounted rate.
